## State of Tennessee Registered Backflow Device Testers (as of 6/24/25)

The installation of a new plumbing system (i.e. landscape/lawn irrigation, fire suppression/sprinklers, commericial building, water well, etc.) or the modification

of an existing one, which would constitute a cross connection hazard, shall be equipped with a backflow prevention device. The City of Brentwood requires that the property owner to have all new installed systems

to tested by a state certified tester with an "Initial Backflow Test" . The "Annual Test" thereafter, will be conducted by our certified contractor hired by the City of Brentwood Water Services under bidded annual contract.

All retests for previously failed backflows from our Annual Testing will need to be submitted with the annual backflow test form. For more info, contact the Utility Programs Coordinator at 615-371-0080 or visit the backflow page on city website.
